Always going beyond his duties, he joyfully embraced his role as a professional and personal mentor to many individuals who are active in the turnaround business and who volunteer in their communities today. Like Peter, winners of this award are TMA Carolinas Chapter members with a long history of industry experience who have made significant contributions to our Chapter.

#### Complete Entry Checklist

All entries must comply with the following for consideration:

- All portions of the entry form must be completed
- Information Release Form, signed by nominee
- Electronic Submission

#### Optional Supporting Attachments

All attachments must be submitted in an electronic format only (PDF is preferred).

Acceptable Attachments:

- Letters of recommendation
- Documents showing TMA involvement
- Thought leadership articles
- Quotations in relevant media
- Relevant awards and distinctions

You may submit a maximum of 5 attachments with your entry. Attachments may not exceed 20 pages each.

### Submitting Your Completed Entry

**There will be no extension or exceptions to the November 3, 2017.** Late, incomplete, or noncompliant entries and/or attachments will not be accepted.

TMA prefers that each entry be submitted as one comprehensive PDF file that includes all components of the entry. The PDF file should be named as the “nominated individual—award name.” If the entrant is unable to create a comprehensive file, each individual PDF file should be titled by the nominee’s name, award name, and respective component of the entry.

### Notification

TMA will email confirmation of receipt upon initial screening of your entry. Award recipients will be recognized at the TMA Carolinas Judges Panel and Holiday Reception schedules for December 4th, 2017. That event will be held at the Charlotte City Club located in Charlotte, NC.

### Judging

Award entries are judged on individual merit. Judges look at each entry for various components, including TMA contributions, committee or board involvement, meeting and conference presentations, contributions to written TMA materials and conferences, educational development efforts, legislative involvement that enhances the industry, etc.
